

**SUMMARY ANNUAL REPORT FOR
ROOFERS UNIONS WELFARE
TRUST FUND**

This is a summary of the annual report for Roofers Unions Welfare Trust Fund, EIN: 36-2226396, for the year ended December 31, 2024. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan was \$110,082,539 as of December 31, 2024, compared to \$103,186,041 as of January 1, 2024. During the plan year, the plan experienced an increase in its net assets from operations by \$6,896,498. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$47,077,323 including (but not limited to) employer contributions of \$38,037,122, participant contributions of \$120,970, realized loss of \$260,196 from the sales of assets and gain from investments of \$9,178,391.

Plan expenses were \$40,180,825. These expenses included \$1,605,063 in administrative expenses and \$38,575,762 in benefits paid to or for participants and beneficiaries.

transactions in excess of 5 percent of plan assets.

The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 2021 Swift Road, Suite B, Oak Brook, IL 60523 and the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs. Paperwork Reduction Act Statement
